Funeral General Price List Survey 2016 Summary

Objective

The Funeral Consumers Alliance of Maine (FCA Maine) periodically conducts a survey of products and services offered by funeral homes and crematories. The objective is gathering price data for services required by the federal law known as the Funeral Rule. We hope this information helps consumers understand products and services available as they compare prices in the state of Maine.

Methodology

In 2016, FCA Maine volunteers collected General Price Lists (GPLs) from funeral homes and crematories in Maine, as we have done in the past. GPLs were gathered by the following methods: visiting the place of business in person to ask for GPL, telephoning and asking for a GPL to be mailed or emailed, emailing the place of business and by gathering those GPLs available on business websites. We attempted to reach all funeral service providers in Maine; we collected GPLs from over 100 funeral homes and crematories. In July 2016, FCA Maine sent a letter to the Maine Funeral Directors Association in Gardiner, Maine explaining the price survey process and asking them to let their membership know about the survey and the need for GPLs. In August, letters were sent to providers we had not yet heard from. We referred to the list of licensed funeral companies posted on the State of Maine Professional & Financial Regulation agency website, lists from I'm Sorry to Hear (an internet listing) and FCA Maine's 2011 survey. If by December 31, 2016 we had no response from the request for GPL, those providers are listed as "did not respond".

It is important to note that price changes can occur at any time. The prices quoted in this survey were in effect in 2016, and the date of effectiveness of each GPL is noted in the survey results.

The price survey results document prices, the cost of specific itemized services as listed on the General Price List. We have no way of valuing the intangible relationship which exists between the funeral home and/or crematory and the community it serves.

Explanation of Spread Sheet Columns in the survey

The columns of prices in the survey are items listed in the federal law The Funeral Rule. Other products and services offered by funeral homes and crematories can be determined by direct contact with the provider. If a column is blank it means that either the provider does not list that item, or we were unable to determine, with reasonable certainty, what the price for that service would be.

FCA Maine is not the offerer of these services. FCA Maine is a non-profit non-sectarian all volunteer organization dedicated to providing education to the public about the many options available in planning disposition of bodily remains. We are also advocates for consumer choice at end-of-life, monitoring pertinent legislation and regulatory activities.

Explanation of Terms on Spread Sheet Columns

- **Basic Services of Funeral Director and staff:** The basic services fee (the so-called "non-declinable fee") includes services that are common to all funerals, regardless of the specific arrangement. These include funeral planning, securing the necessary permits and copies of death certificates, preparing the notices, sheltering the remains, and coordinating the arrangements with the cemetery, crematory or other third parties as well as a share of overhead costs.
- **Transfer of the Body to the Funeral Home**: Transfer of remains from the place of death to funeral home (usually within a 25-mile radius). Additional distance is usually charged at a per mile rate.
- Embalming: Except in certain circumstances embalming is not required by law. Embalming may be necessary if you select certain funeral arrangements, such as a funeral with a viewing. If embalming is not necessary, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation, immediate burial or green burial.
- Use of Facilities and Staff for Visitation/ Viewing at the Funeral Home: The charge for the use of staff and facilities for either viewing or visitation at the funeral home.
- Use of Facilities and Staff for Funeral Ceremony at the Funeral Home: Use of the funeral home facilities and staff for a service commemorating a deceased person with the body present.

- Use of Facilities and Staff for Memorial Service at the Funeral Home: Use of funeral home facilities and staff for a ceremony commemorating a deceased person without the body present.
- Use of Equipment and Staff for Graveside Service: A graveside service commemorates a deceased person and is held at a cemetery before burial.
- Hearse: A charge for the use of the funeral coach (hearse), usually within a 25-mile radius of the funeral home. Additional distance is usually charged at a per mile rate.
- Limousine: Same as above (hearse) except the vehicle is a limousine.
- Forwarding Remains to Another Funeral Home: Usually includes use of preparation room, Basic Services of the funeral director and staff, embalming, transfer of remains, transportation to or from local airport or other place of shipment within a 25-mile radius, service vehicle and obtaining necessary authorizations. This charge applies within the continental US only.
- Receiving Remains from Another Funeral Home: Usually includes Basic Services of the funeral director and staff, transportation of remains to cemetery or crematory, transportation to or from local airport or other place of shipment within a 25-mile radius, service vehicle and obtaining necessary authorizations.
- Direct Cremation: Disposing of remains by cremation without having a formal viewing, visitation, or ceremony with the body present.
- Crematory Fee: a fee charged for cremation. Sometimes the price listed for Direct Cremation includes the crematory fee, and sometimes it does not, in which case it will be an additional fee for the consumer.
- Immediate Burial: disposing of remains by burial without having a formal viewing, visitation, or ceremony with the body present before the graveside service.
- Caskets: a rigid container usually made of wood or metal, designed to hold bodily remains.
- Outer Burial Containers: a structure that partially or completely surrounds a casket in a grave. For example, some outer burial container are called vaults or grave liners.

Funeral Shopping Tips

From the Federal Trade Commission (for more information, visit the FTC website)

•Compare prices from at least two funeral homes.

•Ask for a General Price List. Federal law requires funeral homes to give you written itemized price lists for products and services.

- •Resist pressure to buy goods and services you don't really want or need.
- •Avoid emotional overspending. It's not necessary to have the fanciest casket or the most elaborate funeral to properly honor a loved one.
- •Recognize your rights.
- •Apply the same smart shopping techniques you use for other major purchases.
- •Shop in Advance.

The FTC Funeral Rule (more information available FTC website www.ftc.gov)

The FTC enforces the Funeral Rule, which makes it possible for you to choose only the goods and services you want or need and pay only for those you select. The Rule allows you to compare prices among funeral homes. In brief, the Funeral Rule gives you the right to:

 Buy only the funeral goods and services you want
 Make funeral arrangements without embalming (unless legally required)

 Get price information by telephone
 Get a written itemized price list when you visit a funeral home, a General Price List (GPL) to keep.

 See a written price list for caskets before you see actual caskets
 See a written price list for outer burial containers

 Receive a written statement after you decide what you want, and before you pay
 Use an "alternative container" instead of a casket for cremation

 Provide the funeral home with a casket or urn you purchase elsewhere
 See a written statement after you decide what you want, and before you pay
